#### **OHIO COUNTY COUNTRY FAIR**

To describe the Ohio County Country Fair at a glimpse, it is everything a fair was intended to be. The organization is a non-profit, educational corporation. The mission of the Fair is promotion of agricultural related products and services. Uniquely, this promotion is directed at the non-agricultural public. The Ohio County Country Fair, Inc. owns few physical assets. The Fair's assets are the volunteers who organize and put on this event each year.

The Ohio County Country Fair is held each year in conjunction with Oglebayfest at Oglebay Park in Wheeling, WV. As an integrated part of Oglebayfest, the Fair draws around 60,000 visitors. The Ohio County Country Fair prides itself on being open to the public, meaning no one is charged for admission. Exhibited for premiums are fruits and vegetables, canned goods, baked goods, needlework, quilts, eggs, flower arrangements, scarecrows, pumpkin carvings, and 4-H exhibits. Agricultural and home economic techniques are demonstrated. Farm animals are on hand for attendees to see and touch. Agriculturally related contests are held and are very popular. The Main Tent houses displays from various agricultural trade groups and affiliated organizations.

The Ohio County Country Fair's calling card is its appearance in an empty, grassy field. Over the period of one week, Oglebay Park's Site I is transformed. The Fair appears, occurs Friday, Saturday and Sunday, and the field is returned to an empty, grassy field.

Overall, the Ohio County Country Fair is an intense educational event directed towards making people aware that agriculture is what feeds them. The message is wrapped up in a festive get the public involved atmosphere.

Funding for the Ohio County Country Fair is generally secured through donations. The Fair operates on approximately a fifty thousand dollar budget. The Ohio County Commission is the largest donor, with the West Virginia Division of Culture and History coming in second. Combined, they contribute nearly 50% of the funding. The remainder is made up of corporate and private donations.

- 3. Absolutely no vehicles are permitted on the Ohio County Country Fair Site due to liability concerns. An exhibit drop off area will be provided for any person dropping off many entries.
- 5. Superintendents have the final decision on all matters regarding their department.
- 6. The Ohio County Country Fair encourages participation from the general public.
- 7. Any exhibitor not abiding by the rules or policies of the Ohio County Country Fair will be denied further participation until such exhibitor has been reinstated by the Fair Committee upon review of the matter. Exhibitors shall respect the following:
  - a. All judges will be allowed to perform their duties unobstructed by exhibitors.
  - b. Exhibitors shall behave in a courteous and respectful manner at all times.
  - c. False statements regarding exhibits will not be tolerated.
- 8. The Ohio County Country Fair assumes no responsibility for articles exhibited.
- 9. The Ohio County Country Fair, Inc. will not be held responsible for any injury or damage associated with any contest. The Ohio County Country Fair, Inc. may use photographs of, stories about, and the actual entries themselves as well as all information contained in any Entry Form for publicity and promotion of this event. All entries must conform to the rules and regulations set forth by the Ohio County Country Fair, Inc. The Ohio County Country Fair, Inc. reserves the right to deny exhibition privileges to any entry deemed inappropriate.
- 10. All entries must remain in place until 5:00 p.m. on Sunday of the Fair. Removing your entry before 5:00 p.m. on Sunday will result in forfeiture of any premiums awarded. All remaining items will be discarded after 6:00 p.m.

## OHIO COUNTY 4-H

**Club and 4-H Organizational Exhibits**: All organizational 4-H Community Clubs may enter a group 4-H promotion exhibit by completing an Ohio County Country Fair Participation Form. Other 4-H related organizations may apply to exhibit on a first come, first serve space available basis by completing an Ohio County Country Fair Participation Form. The maximum size of an exhibit is 8' x 2' (one table length) on a table, or 8' x 4' on the ground.

**Cloverbud Exhibits**: All active members of the county 4-H Cloverbuds may exhibit their personal journals/scrap books by registering at the above times.

**Premiums for the 4-H project exhibits are**: 1st place-\$5.00; 2nd place-\$3.00; and 3rd place-\$2.00. Projects will be awarded Blue, Red and White 4-H ribbons for all completed exhibits.

## **DEPARTMENT-4-H PET SHOW-DIVISION-103**

Any active Ohio County 4-H member may enter the Pet Show by pre-registering or registering online at ohiocountycountryfair.fairentry.com by 6:00 pm on Friday, the day of the Pet Show. The show begins at 6:15 p.m. Members may enter only one pet per class. (The WVU Extension and the Ohio County Country Fair Board are not responsible for lost pets). Classes are as follows:

- 01. Dogs all breeds, one class.
- 02. Dog Obedience Class Four commands will be used in this class.Sit/stay; Down/stay; Come on command; heel at different speeds: slow, normal, fast (All will be done with dog on a leash)
- 03. Cats all breeds, one class
- 04. Pocket pets, one class any small animal that is normally caged indoors or carried in the pocket.

05. Dress up - in costume - any pet is eligible as described in one of the above classes.

**Premiums for the Pet Show are**: 1st place-\$15.00; 2nd place-\$10.00; and 3rd place-\$5.00, for each of the categories.

All 4-H premiums will be paid to the 4-H member.

### OHIO COUNTY COUNTRY FAIR LIVESTOCK EXHIBITORS RULES AND REGULATIONS

Exhibits of livestock at the Ohio County Country Fair are done for educational purposes. Consumers seldom see a live animal. Animals are brought to the Fair in an effort to provide an experience-based educational opportunity to fair goers.

Participants have the opportunity to see farm animals and talk with the producers. Exhibits generally represent breeds of animals typically found on local farms. Those exhibiting animals do so through an interest in public awareness. As the public views exhibits in the Livestock Tent, exhibitors are to make an effort to interact with the public regarding the purpose and uses of the animal. Exhibitors should be prepared to provide information regarding the breed, including consumer and end product use. Differences in breeds will be pointed out and if appropriate, a sampling of products may be made available.

Our mission is to promote animal agriculture to the general public. Every effort is to be made to portray a positive image.

## POLICIES AND GUIDELINES FOR EXHIBITORS

- 1. All <u>exhibitors</u> must represent a non-commercial/non-profit educational agriculture or Extension related entity. All requests will be reviewed carefully by the Ohio County Country Fair Board to ensure each entry qualifies under these rules. Decisions of the fair board are final.
- 2. All requests for space must be submitted in writing <u>no later than July 18<sup>th</sup></u> of that current year. The Ohio County Country Fair committee reserves the right to secure additional exhibitors at any time.
- 3. If accepted, all exhibits must be in place before 9:00 a.m. on Saturday and remain intact for the duration of the fair; i.e., Sunday evening at 5:00 p.m.
- 4. All exhibitors selling items **must declare a final profit and forward 10% of that profit, within 30 days**, to the treasurer of the Ohio County Country Fair.
- 5. All exhibits must include an educational display and material for distribution to the public. Examples of handout materials might include recipes, safety tips, environmental information and child care issues.\*
- 6. No alcohol consumption on fairgrounds during fair hours.

#### WV CHAMPIONSHIP PONY PULL RULES AND REGULATIONS

- 1. The distance between the foul lines is to be 13 feet, 6 inches.
- 2. The sled shall be pulled 13 feet, 6 inches.
- 3. Each driver will be given three pulls to pull the sled.
- 4. A team coming to the sled will be given three passes to hook. If not hooked after the third pass, that is a pull, regardless of which pull they are making. A pass is up to the decision of the judges. When the sled is moved two feet or more, it will be considered a pull for any reason, except equipment failure. Out of the trace, if moved two feet is a pull.
- 5. There shall be at least three judges at all times. Decisions made by the judges are final. Judges will be secured by the Superintendent.
- 6. When ponies are called on, the driver and hitcher shall stay behind the hook at all times. The team must remain hooked to take a second pull.
- 7. After the second pull, a driver must unhook his team and wait his turn for his third pull.
- 8. There will be no heading to get hooked to the sled. If at anytime a team has to be headed, they must be unhooked from the sled and come back to it. That is considered as one pass at the sled. An extension will be added to the sled for hooking.
- 9. There is to be only one driver for each team. Drivers cannot be changed after the contest has started, unless there is a valid reason.
- 10. All ponies must stay within the foul lines while pulling. If they step on or over the ropes, they get no distance. The decisions of the judges are final.
- 11. Each team will be given three minutes to hook to the sled and get started after the announcer calls for them. If the team is not hooked and started in the three minutes, they forfeit the pull regardless of which pull they are making. The only exception is for an equipment breakdown.
- 12. The sled will be spotted at 2500# for lightweights and 3000# for all other classes. The judges have the right to have the sled spotted sooner, if in their judgment it is needed for a fair contest.
- 13. After the pull has started, there will be no more than 500# added at any one time. Each class will be pulled separate, unless teamsters agree to pull together because of a lack of participation.
- 14. Teams of ponies in the Lightweight class must not weigh more than 1100#; Middleweight-1400#; Heavyweight-1700#; and Super Heavyweight-2000#.
- 15. All teams entering the contest must be weighed-in before their class starts to pull. Weigh-in begins at 9:00 a.m. and the pull starts at 12:00 Noon.
- 16. All ponies will be allowed only once on the scales. If caught changing ponies after being weighed, the teamster will be barred from the contest.
- 17. There will be three weigh masters, who will be selected by the Superintendent.
- 18. Ponies may be weighed with or without halters. All ponies must pull in the class they weigh. They cannot pull in any class of their choice. A pony can only pull in one class.
- 19. In the event that a class has only one entry, the team must pull on one load.
- 20. Any pony or ponies thought to have been given a stimulant before or during this contest will be given a saliva test. All teamsters must submit their ponies to this test if requested. Those who refuse the test will be disqualified.
- 21. Once ponies arrive on the grounds, there will be no whipping at anytime.
- 22. At no time will a pony be coupled together with anything but checks, lines and doubletrees. No chains, wrenches, bits, etc. are to hang on the harness.

- Titlist certifies and/or agrees to the following: I attest that I am a citizen of the United States of America and a legal resident of the State of West Virginia; that I was born a female; that I have never been married, have never had a marriage annulled, or have never given birth to a child or adopted a child. I agree to remain single during my reign, agree not to become pregnant and understand that if either of these occurs this contract will become null and void. I attest that I have reached my 16<sup>th</sup> birthday by December 31, 2023, and will not have passed my 22<sup>nd</sup> birthday on or before January 1, 2025; that I am of good moral character; that I have not been convicted of a crime; that I have not heretofore made any legal obligations that would prevent or limit my participation as Titlist, and that I am not the current titleholder nor never have been Miss West Virginia Association of Fairs and Festivals.
- 2. I agree that all information provided on my entry form is true and correct.
- 3. I agree that the manner and method of judging and conducting of the pageant was at the sole discretion of the pageant committee, and I further agree that the decision of the judges is final and binding.
- 4. I will serve as the Ohio County Country Fair Queen beginning with my crowning on September 28, 2024 and ending with the 2025 Ohio County Country Fair pageant (date to be determined).
- 5. ## EDGAR HOOPER MEMORIAL SCHOLARSHIP

In order to aid students in pursuit of education supporting an agricultural career, the Ohio County Country Fair Board has enacted the Edgar Hooper Memorial Scholarship. This scholarship, in the amount of \$500, will be awarded annually upon selection by the scholarship committee.

## Eligibility:

- Scholarship available to youth whose home residence is in Brooke, Ohio, or Marshall County.
- Must be a high school senior or enrolled college/technical school student pursuing certification or degree in an agriculturally related field.
- Must have exhibited at the Ohio County Country Fair (OCCF) for at least two out of the last five years. Exhibits may include 4-H projects, livestock animals in the Livestock Tent, and/or entries in any of the contests (Baked Goods, Scarecrow, Flowers, etc.), excluding group entries. At least one exhibit must be in the previous year of application (scholarship is not limited to 4-H and FFA members).
- Must complete fifteen hours of community service. This will consist only of unpaid service. Preference will be given to applicants with documented service to the Ohio County Country Fair.
- Preference will be given to applicants who have a 3.0 grade point average or higher.
- Must submit a complete application (see below).

Application must be complete or it will be rejected. Follow all instructions.

A complete application must include:

- A five hundred (500) word essay will be written by the applicant on the topic, "Why Is It Important to Help People in Urban Communities Understand How Agriculture Impacts Them?"
- The most recent transcript of your grades from high school or college.
- Two letters of recommendation. Please do not include a letter from friends or family, instead reach out to teachers, bosses, etc.
- Record of OCCF exhibitions. These records will be available at the WVU Ohio County Extension Office.
- Volunteer Activity Sheet showing a minimum of 15 volunteer hours of community service. A blank Volunteer Activity Sheet will be provided upon request to the WVU Extension office.
- The application will be due on October 15<sup>th</sup> of each year.

Please mail or drop off your completed application to the WVU Ohio County Extension Office, 51 Sixteenth Street, Room 301, Wheeling, WV 26003 no later than 4pm October 15<sup>th</sup>. Postmark dates or delivery after October 15<sup>th</sup> will not be accepted – no exceptions.

The scholarship is paid directly to the student. The recipient of the scholarship will be announced at the local high school award ceremony. High school senior award recipients will receive the scholarship prior to their first semester in college or technical school once they have provided proof of enrollment. Students enrolled in an advanced educational institution will receive the award immediately.
